"Black Lives" Protest Targets Two Huntington Restaurants

On Monday, June 1st a "Black Lives Matter" march of 200 people shut down parts of downtown Huntington. The march went from New York Avenue to Main Street, and was generally peaceful, without the vandalism and violence that has characterized the Black Lives marches in New York City.

About 100 Suffolk police officers were present. One of the onlookers, Luigi Petrone, a local businessman, posted a private Facebook video of the march, and in response to the widespread vandalism in New York City, described the marches as "savage" and "animals" and joked that if his store was attacked, he would throw "watermelons" at the vandals. That Facebook video was then copied by left wing media blog Long Island Wins and the far-left New York Progressive Action Network, who then organized a street protest of about 30 college-age protesters outside Petrone's restaurant, Tutto Pazzo, on New York Avenue in Halesite.

The protesters shut down the takeout business of the restaurant, and dumped and smashed over 100 watermelons on the restaurant. They spray painted "Eat S..t Luigi," "F...k Tuttopazzo", and "sexual harassment." The protesters also named and attacked members of Petrone's family. No arrests were made.

Former Huntington Town Councilwoman Tracey Edwards (D) - who ran and lost for Huntington Supervisor in 2017 - and is now the head of the local NAACP chapter, demanded that Petrone issue a public apology. "You

need to apologize... You need to make another video - and don't be shy. Apologize to all of us..."

The next day, about 21 college-age Black Lives protesters targeted the Pancho Villa restaurant in downtown Huntington, because its owner, Augie Abbatiello, had briefly appeared in the background of Petrone's Facebook video. Abbatiello, who was not part of Petrone's remarks, apologized profusely in a Newsday video, with protesters all around.

"Everyone is saying 'You messed up' and that 'Silence is the new racism,'" confessed Abbatiello." I learned, and I am going to try to get better from this..." Abbatiello served drinks and treats to the protesters to try to diffuse the situation.

Frankenstein's Political Monsters

After you spend decades teaching an entire generation that America is a cesspool of race hatred and class warfare, it should come as no shock that millions of young people have come to embrace revolution. The brutality of Burke - and police killings of innocent white victims (such as the killing of housewife Justine Damond by a black Minneapolis police officer in 2017) never resulted in widespread protests.

The Democratic politicians cheering on today's rioters - such as Huntington's Tracey Edwards - were all strangely silent then.

And that is why today's protests and riots are about something else: political power.

Since the fall of Soviet communism, the hard left in America has spread the poison of revolution, race hatred and class warfare. Violent leftist shock troops like Antifa have had lavish funding and free rein in America's colleges and sanctuary cities. And through he likes of Obama, Soros, and many left-wing mayors, tens of billions in funding have flowed to them under the guise of "community organizing."

Today, when a violent rioter is arrested, their comrades are so well organized that their lawyers are already waiting at the police stations to secure their release, for the next night's riots. If America wants to commit suicide, then the policy of coddling violent left-wing rioters - and the teaching of the historically inaccurate narratives of race and class oppression in today's America - is the way to go. No other country teaches their children that they are a rotten country that should be destroyed. America is special in that regard.

The riots have been a terrible wake-up call. We need to learn - and re-ground our country

REOPEN PHASE 1

To the Editor:

Glad that we can start Phase 1 in our wonderful Hamlet!!!

Here are some tips for a safe reopening from NYS. Please go to Forward.NY.Gov for complete details.

Phase 1 includes low-risk businesses involved in construction, manufacturing, and wholesale trade, agriculture, fishing, forestry, and hunting, and select retail for curbside or in store pickup or drop-off. Businesses in both Nassau and Suffolk Counties will be part of this reopening.

Eight other sections of New York State have already started to reopen: the Capital Region, Central New York, Finger Lakes, mid-Hudson, Mohawk Valley, North Country, Southern Tier, and Western New York. The only other region not to reopen is New York City.

What are the protocols for these Phase 1 businesses?

Residential-commercial construction:

All workers must have masks and wear them within 6 feet of another worker. Employers must provide masks for all employees. No congregate meetings.

Retail Business owners- curbside pickup:

Employee and purchaser in vehicle must wear a mask, and gloves are preferred. Hand sanitizer must be made available.

Retail Business owners- in store pickup:

Requires ordering ahead with pre-arranged orders. Social distancing required in store. No more than 50% of maximum occupancy. Patrons must wear masks, and gloves are preferred. Hand sanitizer must be made available.

The more we follow these rules the safer it will be for ALL of us and the quicker that we will be able to get to PHASE 2,3, and 4!!!

North Shore Absentee Ballots and 2020-21 Budget Proposal

As many of you know by now, this year's budget vote and trustee election is being held exclusively by absentee vote. As a result, many of you should have received ballots in the mail. As a reminder, all ballots must be received by Tuesday, June 9, 2020 and by no later than 5 PM. Your confidence and trust in us and our work on behalf of the children we share is one of the most important things I set out to earn. Thus, I thought it would be helpful to share a few thoughts as the voting process gets underway.

We have been and will continue to take every measure to ensure a safe and fairelection process. Absentee ballots are received either by mail or via the Mail Drop at the Central Office. The ballot itself is sealed, anonymous and they will be collected and cataloged each day by our District Clerk. We are adhering to stringent protocols set forth in the law and are taking careful direction from counsel. Ballots will not be opened until after 5 PM on June 9, 2020. Each year, we tally absentee ballots in a highly prescriptive way that preserves the integrity of both the voting process as well as the voter. This year will be no exception, and as is always the case, an attorney will be present to oversee the tallying process. Each candidate will have an opportunity to be directly informed. Lastly, and importantly, anyone is welcome to contact our District Clerk, Ms. Elizabeth Ciampi at ciampib@northshoreschools.org, with any questions about ballots and/or the process in general.

The proposed budget was crafted and built to preserve the excellence of all of our existing programs. This includes maintaining our current class sizes and all electives, co-curricular, and extra-curricular activities for our K-12 student body. The Board directed me to present a budget that accounted for the continuation of programming and cuts were made by the Board of Education throughout the process. Thus, while there are certainly new courses to meet student interest and/or need, there are not additional or new programs in the proposed budget. Student support services, such as wellness for all elementary students, counseling and other instructional supports for new English speakers, and the

expansion of special education programming are all included in the proposed budget. Additionally, the continuation of existing programming such as mandarin, computer science, and dance are funded to support continued student interest. Otherwise, the proposed staffing model only continues to support exactly what exists now. It is important to note that some, if not many of our program needs may need to shift in the fall. This will be largely dependent upon they type of instruction that we will be engaged in (face-to-face, online, or a hybrid of both). If the proposed budget fails and the District must adopt a contingency budget, approximately \$2.7M in program cuts will need to be made.

Ours schools are so successful because we have amazing students with engaged families who are taught by excellent teachers. They are among the best in the nation and I love them. It bears noting that 95% of the Class of 2019 left North Shore to attend college and 76% of them were accepted to the "Most Highly Competitive" and "Highly Competitive" colleges and universities in the country. The remaining 5% went on to pursue careers in the workforce and/or the military. I am proud of all of them as they continue to represent North Shore with esteem.

On the Ballot will be Proposition 1 (The School Budget: represents a 2.33% budget-to-budget increase and is under the tax cap), Proposition 2, (The Capital Reserve: it only authorizes the District to access existing funds that are currently in reserves at no additional cost to our taxpayers in an amount not to exceed \$3 million for the renovation to the Glen Head School nurse's office and North Shore Middle School locker rooms), and the Election of Trustees (it is a contested election with 3 candidates and 2 seats. The bios of Richard Galati, Andrea Macari, and Robert Mazzella can e found on our school website at www.northshoreschools.org).

Oakcliff Pioneers Safe Covid-19 Quaranteam Regatta

Oakcliff in Oyster Bay continues to lead the way towards safe Covid-19 boating. Just days after the start of the quarantine, the Oakcliff team began developing a protocol and product recommendation list for hosting sailboat regattas that can be applied to the general boating population to keep people safe while using sanitation procedures that are as environmentally-friendly as possible. View Oakcliff's full "Covid-19 Boating Safety Protocol."

On the weekend of June 6-7, Oakcliff will test their protocol for the first time

during their Quaranteam Regatta. The crews of 5 or 6 on each boat will consist of a household or a quarantine team of sailors who mutually attest to one another that they have been safely and strictly quarantined for at least two weeks prior. Oakcliff has created an affidavit to formalize the team's agreement and may implement testing in the

future if it becomes more reliable and widely available.

To keep teams socially distanced from one another while on site, Oakcliff will transport one team at a time to their boats, with the driver separated from the crew by a line designating a 6-foot boundary. At all times, including during racing, the competitors will be required to wear face covers. Oakcliff has developed and is producing athletic face coverings that offer UV protection and are antimicrobial and wicking. The face coverings also have a straw hole (patent-pending) in the back.
