

## Glen Cove VFW, American Legion Receives \$10K in Grants

Veterans of Foreign Wars (VFW) Post 347 and American Legion Post 1765 have each received \$10,000 Nassau County grants - funds that will support their ongoing service to Glen Cove's veterans and the greater community.

The grants, which are funded using a portion of Nassau's federal American Rescue Plan Act (ARPA) allotment, came at an optimal time for both organizations. VFW Post 347 is still rebuilding from an August 2021 blaze that rendered the hall unusable. Both VFW Post 347 and American Legion Post 1765, like so many other institutions, are continuing to recover financially from economic disruptions caused by the worst of the COVID-19 pandemic.

"For generations, the members of VFW Post 347 and American Legion Post 1765 have given back so much to the men and women who served our nation, and this grant program is just one token of Nassau County's appreciation for their service," Nassau County Legislator Delia DeRiggi-Whitton (D - Glen Cove) said. # Fire Destroys Police HQ in Woodbury

A fast-moving fire at the Nassau County Police Department's Second Precinct in Woodbury destroyed the police precinct building and injured sev-

eral firefighters.

The fire occurred at the Nassau County Police Department's Second Precinct, located at 7700 Jericho Turnpike, on Saturday, 26 November, at

about 10:15PM. The fire started in the precinct building's kitchen area, and then spread to two adjoining offices.

Fire fighters from the Syosset Fire Department and several other surrounding fire departments rushed to the scene and extinguished the flames. Detectives from the Arson/Bomb Squad and Fire Marshals also came to the scene to investigate the source of the fire, but their investigation concluded that the fire was not the result of a foul play.

Six police employees who were in the building when the fire started were treated at Nassau University Medical Center for smoke inhalation, Police Commissioner Patrick Ryder said.

Nassau County Executive Bruce Blakeman said the damage from the fire left the building "not salvageable." It is not yet clear what repairing or rebuilding the precinct building would require.

The police said that there would be no interruptions of the Nassau County Police-related services. Members of the Second Precinct will temporarily move to the Eighth Precinct building.

Residents who need to contact the Second Precinct can still call 516-573-6200 or dial 911 in case of an emergency. The Second Precinct covers Bayville, East Norwich, Hicksville, Jericho, Lattingtown, Locust Valley, Oyster Bay, Plainview, Syosset, Westbury and Woodbury.

## Masked Thugs Rob Stores in Huntington

The New York crime wave reached into Huntington with a series of brazen thefts by masked thugs.

Criminals continue to take advantage of Covid "masking" policies. Where wearing masks indoors was once suspicious, now it's "normal" and enables criminals to hide their identities.

Suffolk Police are seeking three men - dubbed the "Black Mask Crew" who stole credit cards from a gym locker at LA Fitness on West Jericho Turnpike in West Hills. The criminals then used the cards to make over \$2,000 in purchases at the BJ's in Farmingdale.

Suffolk Police are also seeking three people - dubbed the "White Mask Crew" who stole \$4,000 in allergy medicines from the Target store on East Jericho Turnpike in Huntington Station.

The common factor in both sets of thefts was that the criminals wore Covid face masks to conceal their identities, while brazenly and openly committing their crimes.

## Arrest in Oyster Bay

The Second Squad reports the details of an arrest for an incident that occurred on Sunday, October 9, 2022 at 6:15 pm in Oyster Bay.

According to the Nassau County Police Department they responded to a 911 call for a disturbance at Theodore Roosevelt Marina located at 5 Bay Avenue. Upon arrival, it was determined that Omar Romerobulnes, 33, was involved in a verbal altercation with a female victim and a physical altercation with a male witness at the scene. Romerobulnes proceeded to punch the male victim causing pain and physical injury. Officers attempted to place Defendant

under arrest and he resisted, refusing to comply with verbal commands. The defendant acted violently and combative while resisting arrest and caused an injury to an officer. Both the officer and the defendant were transported to a nearby hospitals for assessment and treatment.

Omar Romerobulnes is charged with Assault 2nd Degree, Assault 3rd Degree, Harassment 2nd Degree, Obstructing a Governmental Administration 2nd Degree and Resisting Arrest. He was arraigned on Monday, October 10, 2022 at First District Court, 99 Main Street, Hempstead.

## EDITORIAL

### “SANTA” JOE SALADINO SHOWS THE SPIRIT OF CHRISTMAS

The horrific fire in the Huntington sanitation truck storage lot on December 2nd destroyed six Town sanitation trucks. The Town suddenly faced a garbage crisis, as it would take weeks - maybe months - to replace the trucks.

Then - in the true spirit of Christmas - Oyster Bay Town Supervisor Joe Saladino jumped-in and offered five surplus trucks from Oyster Bay - to cover Huntington's carting shortages until replacement trucks could arrive.

Saladino's "good neighbor" policy is exactly why so many people love the North Shore - the sense of community and working together - to help our communities and neighbors. Saladino didn't wait for someone to ask him - he knew that Oyster Bay had the ability to loan the trucks - saving Huntington from a garbage crisis - while not impacting Oyster Bay's own services.

That simple kindness and eagerness to help people is why Saladino was returned with 72% of the vote in the last election - and why he now has his 220,000 neighbors in Huntington all now saying "Thank You."

### NO ROOM FOR "ANTI-BIAS" HATE IN HUNTINGTON

Huntington's controversial "Anti-Bias" Task Force was long a haven for left-wing extremists, who used their official town committee to improperly influence elections, and whose targets have included the rising Hispanic religious communities in Huntington.

In two recent incidents, the formerly mostly-white and radical members of the Task Force used their official positions to slander Hispanic Republicans - even making blatantly false charges of "anti-Semitism" against one Hispanic candidate in the middle of the 2021 election. That is called "election interference" and "bigotry" and "bias."

The Town Board last month reformed the Task Force, replacing former extremist members with five new - mostly-minority - and far more centrist - appointees.

Now Councilwoman Joan Cergol (D) has introduced a Town Board resolution to put back the extremist radicals - whose misconduct promoted the Town's actions to remove and replace them. Cergol is up for re-election in 2023 and apparently needs all the "friends" she can find - no matter how bigoted or extremist.

No one has a right to use town government as a platform to slander other people and promote hate. The Town itself can - and should - be sued when that happens. But more importantly, no Town Board member should empower bigots who have smeared Hispanic residents. That's called "empowering bigots."

A former US President has been condemned for recently inviting bigots and extremists into his Mar-a-Lago resort.

Let's hope that the members of the Huntington Town Board have enough common sense to not invite bigots back into an official Town office. At a minimum, they should ask the Hispanic community - and people who have been past targets of the Task Force - what they think. There is no room for Hate in Huntington.

### BLUE CHRISTMAS

To the Editor:

'Tis the season to be jolly, but Christmas can also be a difficult time for aging family members.

Holidays are a time of tradition, family, and reflection, and there's a lot of value and strength in that.

Reminiscing about Christmases past can have a positive outcome, but it can also churn up some negative feelings.

The paradigm holds true for people of all backgrounds, but the older one gets, the greater the chance for the loss of a spouse or other loved one during the course of the year, which can influence the holidays. Families could also experience other changes in dynamics, including marriage or divorce.

Thinking about unpleasant or stressful life changes can cast a dark shadow over what was once an enjoyable holiday, especially in the twilight of the COVID-19 pandemic. For most of us, life has returned to normal. But for immunocompromised individuals - often including the aging population - the risk of becoming ill remains a threat.

I suggests that there might also be

another reason for feeling down during the holidays - Seasonal Affective Disorder (SAD), in which an individual who otherwise has normal mental health can experience symptoms of depression based on the time of year. One possibility is that SAD is related to a lack of the biochemical serotonin, which is thought to be a contributor to feelings of well-being and happiness.

Because sunlight stimulates the production of serotonin in one's body, winter's shorter days might be partly to blame for changes in mood.

A therapy lamp - which emulates natural light - might help push away

the holiday blues. Daytime walks might also help seniors to feel better. I also suggests drinking more water and getting more exercise.

I have worked in the field of aging and disabilities for decades as an administrator, clinician, and educator. I authored and collaborated on books, articles, and technical reports that address topics of aging policy, Alzheimer's disease, family caregiving, and end-of-life care.

# Op-Ed: The So-Called International Climate Deal is Nothing More than Reparations to Poor Countries

With great fanfare, national representatives meeting at a climate conference in Egypt gave each other high-fives as they announced the framework of a new climate deal that will supposedly save the planet. In actuality, it's a virtue signaling joke. The deal reiterates the goal of nations to cobble together \$100 billion to fight climate change and calls for wealthier nations to give money to poor nations - in part to make up for their past practices and in part to help the poorer countries to implement renewable energy systems.

Does anyone think these poor coun-

tries are going to funnel money to more expensive renewable energy when their bigger concern is preventing their people from starving?

Of course, this plan will assume that it is the United States that comes up with the lion's share of these reparations. Liberals like John Kerry will be jumping through hoops to make that happen.

Meanwhile, China is exempt from giving money or curbing emissions and is still being classified as a "developing nation" even though it is the world's second richest nation, and pollutes more than any other country.

From 2004 to 2019 the world's carbon footprint increased 26% - although carbon output in the US dropped 14%. This was primarily due to America's increased use of cleaner natural gas to replace coal.

The US only has about 15 coal plants remaining. Even if we closed all of them, it would not even be a blip on the world carbon footprint. That's because China has thousands of coal plants - and continues to build thousands more each year.

We should indeed continue our foreign aid packages. But we should tie them to human rights, the rejection of terrorism, and the receiving nation's partnership with our nation.

The hundred billion being discussed will probably never come to fruition. If it does, it should be spent on eliminating poverty, not being placed into so-called

climate projects of dubious worth.

The best way to solve the climate problem on the planet is to promote newer technology that makes renewables cheaper.

Then these countries will gravitate toward these renewable energy systems on their own, without the need to ineffectively bribe them to do so.



## Huntington to Legalize Basement Apartments ?

A new proposal would allow basement units under the town's accessory apartment code. The proposal comes from three members of the Huntington Town Board.

The bill is being cosponsored by council members Sal Ferro, Dave Bennardo and Joan Cergol. In 2019, basement apartments were banned by the board.

Ferro argues that basement apartments could put homeowners concerned about storage at ease. If the new proposal were to go into effect, residents hoping

"We would really like a way to help seniors stay in their homes and provide housing," Ferro said. "It has to be an owner occupied house. This is not about creating investment opportunities, and we're not looking to create two-family homes."

The next meeting is scheduled for December 13 at 2 PM.

## CSH's "Bedlam Street" Historic Bar Crawl

Cold Spring Harbor rose to prominence in the mid-19th century thanks to its whaling industry – a local industry made possible by local businessmen brothers John and Walter Jones who, over a period of 26 years (1836-1862), oversaw forty-four voyages with nine ships.

Whaling was a profitable but a very risky business. Sailors were often lost in voyages that took up to two years.

Herman Melville, of "Moby Dick" fame, in 1841, shipped out of New Bedford, just across Long Island Sound, on the whaler "Acushnet".

Melville jumped ship after 18 months in the Marquesas Islands and then took part in a mutiny on another whaler, ending up in Tahiti.

It is not surprising then, that when whale men finally reached their home port - they were ready not just for a good meal – and some raucous fun.

Last weekend, the Cold Spring Harbor Whaling Museum commemorated those tumultuous homecomings, when the entire community would turn out upon hearing the cannon shot announcing a whaling ship's return. The Museum hosted the first annual "Bedlam Street Bash."

Main Street was then colloquially

known then as "Bedlam Street," since the homecoming sailors, flush with cash, grateful to be alive, and most likely more interested in wild drunken partying than church-going, would "paint the town red."

At the original Bedlam Street parties, crowds of drunken whalers would wander up and down Main Street. There were shanties, scrimshaw, fresh food and alcoholic drink – and lots of fun.

The Whaling Museum put on a far tamer version last weekend, with little heavy drinking, brawling or public intoxication evident.

It looks like another Cold Spring Harbor tradition has been revived – albeit much more subdued.


The Next Chapter is run by Mallory Braun, a former rare books manager at Book Revue. She was able to open in part due to successful fundraising.





# Rest in Peace Queen Elizabeth II

With the recent passing of Queen Elizabeth II American fascination with the British Royal family is more apparent than ever.

The Queen was Monarch of Great Britain, Northern Ireland and fifty-four countries of the Commonwealth for seventy years. She celebrated her 96th birthday on April 21st, not to be confused with her "official" birthday, which was celebrated in June as the weather is better, although not always. She was the longest reigning monarch in the world and was

entered into the Guinness Book of World Records following the death of the King of Thailand, at age 88 in October 2016.

It seems somewhat ironic that Americans fought for their independence from King George III, but they adore the Queen. Elizabeth Alexandra Mary Windsor wasn't born to be queen. She was born a princess, the eldest daughter of Prince Albert, Duke of York, the second son of King George V. Prince Albert became King George VI when his brother, the Prince of Wales, briefly King Edward VIII, abdicated after a short time to marry a twice divorced American woman. At eleven years old Princess Elizabeth then became next in line for the throne. King George died at the age of fifty-two when she was twenty-five years old, and she became queen on his death.

Her coronation was the following year on June 2, 1953. At that time, she was married to Prince Phillip and had two young children, Prince Charles, now King Charles III, and Princess Anne.

The recent celebrations of the Queen's Platinum Jubilee almost made it seem that she would live as long or longer than her mother, Queen Elizabeth

the Queen Mother, who was known affectionately as the Queen Mum, and lived to be 101. The Queen's husband of seventy-three years, Prince Philip, died at the age of 99 in 2021, a few months short of his 100th birthday.

People from all over the world attended The Queen's funeral, and thousands travelled and waited for hours to view her coffin in Edinburgh, Scotland and at Westminster Hall in London, and many more thousands watched on televisions all over the world.

As someone who grew up in England, I have become more interested in the Royal Family since living in the United States. Just like many other Americans whose ancestors came from other countries, we enjoy both our American citizenship and heritage of origin.

The news of the Queen's death seemed to affect people almost as the loss of a family member. Many people had never known another monarch in their lifetime, she was a constant presence, and looked upon as mother and/or

grandmother of the nation, if not the world.

During the Changing of the Guard two days after 9/11/01, the Queen had the Cold Stream Guards play the American National Anthem, the Star-Spangled Banner, breaking with centuries of tradition. Another tradition was broken when Princess Anne, the Queen's only daughter, stood in a vigil in her full navy ceremonial uniform, at the coffin with her three brothers, a ceremony previously reserved only for princes.

Now we anticipate the coronation next year of King Charles III, who was heir to the throne longer than any other monarch.



